

***If I am an Eligible Owner of a 3.0L diesel Generation One (model years 2009-2012) or Generation Two (model years 2013-2016) vehicle, how do I show that I owned my vehicle on November 2, 2015?***

When making a claim, Eligible Owners need to provide, among other documentation, proof of ownership that they owned their vehicle on November 2, 2015.

The following are acceptable proof of ownership documents: your bill of sale or vehicle registration certificate covering the date November 2, 2015. If you no longer have these documents, below are suggestions for how you may be able to obtain copies of the information.

If you intend to rely upon other forms of proof of ownership, such as a U.S. certificate of title, probated will or court order, we recommend contacting the Canadian Settlement Claims Centre at 1-888-6704773.

In addition to these identified forms of proof, the Claims Administrator may ask you to provide additional documents depending on the circumstances of your claim.

Bill of Sale

If you no longer have your bill of sale, you may be able to obtain a copy from the dealership where you purchased your vehicle. In some cases, there may be a delay in receiving a copy or, due to the age of the records or other circumstances, the dealership may not have a copy. As an alternative, if you provided your bill of sale to your insurer or financial institution, you may be able to obtain copies from them.

Vehicle Registration Certificate

If you no longer have your old vehicle registration certificate, you may be able to obtain a vehicle record (e.g., an abstract identifying you as the registered owner as of November 2, 2015) from your provincial Ministry of Transportation or other regulatory authority. A modest fee may apply. Please note that, because access to information rules and services differ across Canada, we recommend consulting the appropriate authority at the contact information shown below.
